- Promote Books Inc.'s YA events on personal social media accounts, specifically those hosted in their store
- Write Shelf Talkers for the YA section
- Come up with fun themes and craft ideas for future meetings
- Give buying advice to the Books Inc. Children's specialist
- Nominate a Buzz Book
- Give feedback and advice on NYMBC Teen Events
- Interview YA authors
- Create fun book themed events for their respective store
- Volunteer at author events
- Recruit fellow book lovers for the Teen Advisory Board
- Attend other Books Inc. Events
- Read and have fun!

Meeting Format

Each meeting will be 1-2 hours long depending on the pre-planned activities, and will be supervised by the Books Inc. Children's specialist or Manager. At our August meeting we will discuss, as a group, what

the members want to accomplish or do at each meeting. However, the most important thing we'll do is talk about books! Review them, write shelf-talkers, and convince the Books Inc. Children's Specialist on what we HAVE to have on our shelves.

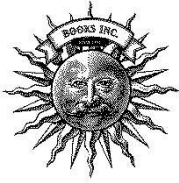
